RULES & ENTRY FORM

TEAMS : Each team will consist of two members. Participants must be 18 years or older. All participants must sign a waiver of liability.

REGISTRATION: Entry form is available online at www.eugenecelebration.com. Entrants may submit their entries by email: events@eugenecelebration.com, fax: (877) 568-3411, mail: Eugene Celebration, PO Box 11647, Eugene OR 97440, or drop off at our office: 1038 Willamette St., Eugene, OR 97401 (usually open Monday through Friday, 10 a.m. to 4 p.m.) **Space is limited to the first 16 teams and entries will be processed on a first-come, first-served basis.** Registration will be confirmed by email.

ENTRY FEE: Free!

PRIZES: First Place winner will receive a \$100 Unique Eugene gift certificate. Second Place winner will receive a \$50 Unique Eugene gift certificate.

Each participant will receive a free Eugene Celebration admission wristband, good for entry to the Eugene Celebration throughout the weekend **and** will be entered in a drawing for other great prizes!

SUPPLIES: Each participant must supply his/her own apron. All other supplies will be provided by the event organizers.

FORMAT & COURSE: The format is a relay race with two teams per heat. The winning team from each heat will move on to the next round. The participants of the final round will be awarded First and Second Place. A consolation race between the losing teams from the semi-finals will be run to determine the Third Place winner.

The object of the race is to carry a tray of beverages through several obstacles (e.g. a zigzag beer keg course) and skill challenges (e.g. mixing and serving drinks to "customers"), speed-walking as fast as possible with minimal spillage.

The race runs east along 8th Avenue from Olive Street to just west of the Parcade (inside the Eugene Celebration wristband checkpoint), and back to Olive Street.

SCORING: Winner of each heat will be determined by speed, accuracy of drink mixing and (lack of) spillage. Format and scoring details will be provided to participants prior to the event.

RACE DAY PROCEDURES FOR WAITER OLYMPICS PARTICIPANTS: Race begins on Saturday, August 27th, 2011 at 2 p.m. at 8th Avenue at Olive Street. Teams must be at the starting line 30 minutes before the posted start time. Prizes will be awarded immediately following the races at the stage near 8th Avenue and Olive Street.
